#### Module Area A: Language

(Responsible for the Module Area: Sprachenzentrum)

# **Learning Objectives**

Objective of this module area is the mediation of subject specific language skills. In the increasingly internationalized sciences, the acquaintance with technical terminology is a prerequisite. In the courses of this module area, the students will learn a repertoire of essential legal terminology that will ensure subject specific conversation and working opportunities outside of Germany and in the international arena.

#### **Learning Content**

All courses mediate subject specific English skills applied on legal issues.

#### Type of Knowledge Transfer

The module area may be completed throughout the entire course of the additional study program

#### **Participation Requirements**

Successful completion of:

#### **Performance Report**

Students must complete an examination according to the nature of the respective course. Usually this is in the shape of a written exam, the lecturer may determine the type of examination.

If a student fails to successfully complete the examination the repeat examination must be completed within the course of the additional study program. Examinations will be generated according § 8 of the examination and study regulations (PSO).

#### **Calculation of Student Workload**

The students have to complete 4-ECTS in the Module Area A: Language.

#### Credits

#### **Module Area B: Comparative Law**

(Responsible for the Module Area: Professorship for African Legal Studies)

#### **Learning Objectives**

Objective of this module area is the mediation of fundamental questions, issues, and theoretical approaches in comparative law. Students will acquire skills to comprehend, critically assess and compare different legal systems in various geographic regions. Lectures and seminars will offer the students in-depth discussions on socio-political discourses beyond the German legal systems and introductions into alternative legal systems. This module area is a possibility to translate familiar issues into other geographies and social structures in order to widen the horizon.

# **Learning Content**

The modules mediate (a) academic, theoretical, and subject historical foundations, as we as (b) important legal issues, scientific knowledge, and the basis of comparative law.

# Type of Knowledge Transfer

The Module Area consists of various types of courses, including lectures, tutorials, and seminars. Depending on the respective course, the form may vary. Additional information can be found in the module plan and on CampusOnline.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

Students must complete an examination according to the nature of the respective course. Usually this is in the shape of a written exam, the lecturer may determine the type of examination.

If a student fails to successfully complete the examination the repeat examination must be completed within the course of the additional study program. Examinations will be generated according § 8 of the examination and study regulations (PSO).

(Responsible for the Module Area: Professorship for African Legal Studies)

#### **Learning Objectives**

# **Module Area D: African Perspectives and Law**

(Responsible for the Module Area: Professorship for African Legal Studies)

# **Learning Objectives**

Ziel dieses einzigartigen Module Areas ist die interdisziplinäre Vermittlung rechtlicher Themenkomplexe in Bezug auf den afrikanischen Kontinent. Die rechtlichen Grundlagen vermittelt in den Lehrveranstaltungen werden ergänzt durch einen Einblick in sozio-politische und geschichtliche Hintergründe, welche die Entwicklung auf dem afrikanischen Kontinent prägen. Durch Verknüpfung soziologischer, juristischer und politischer Veranstaltungen eröffnet es den Studierenden sich differenzierter wichtigen sozialen Fragen zu nähern und der rechtlichen Perspektive, um einen kritischen sozialwissenschaftlichen Blick zu ergänzen.

# **Learning Content**

# **Actors in Development Policies**

#### **Learning Objectives**

The course aims to enable students to develop critical thinking about the nature and process of development cooperation. The different faces of international relations will be considered in order to understand the changing face of development cooperation. By the end of the course, students will be able to interpret the various forms of international development cooperation, processes and practices.

#### **Learning Content**

The module is designed for students interested in international development cooperation in Africa and the relations between Africa and the rest of the world. The course looks at the main actors on the ground and behind the scenes and analyzes their patterns of interaction.

# Type of Knowledge Transfer

The module is held in the form of a seminar in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course is completed with a written paper (12-15 pages) and presentation.

#### **Calculation of Student Workload**

For the module 4 SWS are required, consisting of 2 SWS for the lecture and 2 SWS for the accompanying tutorial. In addition, students are expected to spend additional time for the preparation and follow-up of the module, as well as for the preparation of examinations.

#### **Credits**

The module is credited with 6-ECTS.

#### **Frequency of Occurence**

The course will be held in the winter semester.

# Verknüpfung mit anderen Module Areaen

#### **Constitutional Law and Constitutionalism in Africa**

#### **Learning Objectives**

The course provides an overview of key constitutional moments and the role of citizens and legal institutions in the creation of constitutional law. It serves to introduce students to the exciting development of constitutional law and jurisprudence in selected African jurisdictions.

#### **Learning Content**

This comparative law course introduces students to the constitutional law of selected African countries. The modules combines thematic discussions of a variety of constitutional systems, how constitutions come into being and how they are repealed, and the politics behind key constitutional moments. Themes that run like a thread through the course include: the interplay between constitutional law and politics, and between constitutional law and international law; tensions between constitutionalism and democracy.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

# **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course may be completed with an oral examination or written paper.

#### **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### Credits

The module is credited with 5-ECTS.

# **Frequency of Occurence**

The course will be held in the summer semester.

# **Linkage to other Module Areas**

#### **Development in Postcolonial Africa**

#### **Learning Objectives**

This module examines the development initiatives launched by African leaders since the attainment of political independence. The study will examine issues of ideology, concepts of development, and the linkage of development issues to nationalism, nation-building, state-building, politics of belonging, citizenship, social cohesion, and poverty alleviation in Africa.

# **Learning Content**

Using case studies, the module explains specific development plans, explanations and charters, and practical steps to implement development. Why development has failed to occur in Africa is discussed in class.

#### Type of Knowledge Transfer

The module is held in the form of an advanced seminar in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course must be completed with a presentation and a seminar paper.

#### **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The course is credited with 5-ECTS.

#### **Frequency of Occurence**

The course will be held in the winter- and summer semester.

#### **Linkage to other Module Areas**

# **Development Policies (Knowledge in Development Studies)**

# **Learning Objectives**

The seminar therefore examines the concept of development itself as shaped by a particular epistemology (knowledge), questions the normative foundations of development thinking, and critiques not only classical economic thinking but also economic science. Using empirical examples from Africa in particular and the global South in general, the seminar argues for disentanglement, ownership and self-improvement, unencumbered by global colonial power matrices.

# **Learning Content**

Development as an idea, discourse, concept, ideology, and practice continues to be the subject of lively debate. This seminar engages in the debate from the perspective of the decolonial epistemic turn. It emphasizes the importance of how knowledge creates reality (how epistemology frames ontology). In this context, viewing development as epistemic creation leads to recognizing the central role of epistemic crisis in the impasse of development.

# Type of Knowledge Transfer

The module is held in the form of an advanced seminar in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

# **Performance Report**

The course may be completed with a written term paper.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The course is credited with 5-ECTS.

#### **Frequency of Occurence**

The course will be held in the winter semester

#### **Linkage to other Module Areas**

#### **Development Policies: Selected Issues**

#### **Learning Objectives**

Students will be able to analyze specific development policies, particularly their dynamics and the conditions for their success or failure. While specific topics will vary, all seminars in this module will cover the state and key features of the Sustainable Development Goals process, sharpening students' ability to understand and evaluate the global agenda that will shape development policies worldwide until at least 2030.

# **Learning Content**

This seminar addresses selected development policy issues, i.e., specific areas of development action such as health or education policy, global trade negotiations, or the interface between security and development issues, to name a few options. The specific content of the seminar varies to provide students with a broad choice. However, the topic is always related to the global sustainable development agenda, and the least developed countries on African soil receive special attention.

# Type of Knowledge Transfer

The module is held in the form of a seminar in which students are encouraged to actively participate.

# **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft). Students are recommended to have prior knowledge in Sociology of Development or Development Policies.

#### **Performance Report**

The course will be completed with a written paper and presentation.

#### **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the winter semester.

# **Linkage to other Module Areas**

#### **Einfaches Seminar: Economic and Business Law**

#### **Learning Objectives**

The seminar is offered as a block seminar and is concluded with a seminar paper.

# **Learning Content**

The selection of topics will vary each semester depending on the topic of the main seminar.

# **Type of Knowledge Transfer**

The module is held in the form of an advanced seminar, in which students are required to actively participate and to submit the seminar paper and its presentation.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course can be completed with a written seminar paper and its presentation. The paper as well as the presentation must be submitted and presented in English for International Legal Studies.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### Credits

The module is credited with 6-ECTS.

#### **Frequency of Occurence**

The module will be held in the winter- and summer semester.

#### **Linkage to other Module Areas**

The module is held in the form of an advanced seminar, in which students are required to actively participate and to submit the seminar paper and its presentation.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course can be completed with a written seminar paper and its presentation. The paper as well as the presentation must be submitted and presented in English for International Legal Studies.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### Credits

The module is credited with 6-ECTS.

#### **Frequency of Occurence**

The module will be held in the winter- and summer semester.

#### **Linkage to other Module Areas**

#### **Elements of Contract and Tort Law**

#### **Learning Objectives**

The aim of the module is to provide you with the opportunity to gain practical insight into the key elements of English contract and tort law. This objective will be achieved through the study of case law, legislation, contract provisions and academic literature referred to in the syllabus.

# **Learning Content**

The module examines contract and tort in the context of common law with some comparisons to civil law systems. You will be introduced to the basic principles of the subject and have the opportunity to acquire a deeper knowledge and understanding of the legal rules governing contracts and torts.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course is completed with a written paper.

#### **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the summer semester.

#### **Linkage to other Module Areas**

#### **EU Capital Markets Law**

#### **Learning Objectives**

Students are introduced to EU policy and legislation and to the case law of the European Court of Justice.

#### **Learning Content**

EU policy and legislation in the area of capital markets, covering both relevant EU legislation (e.g. Prospectus Regulation, Market Abuse Regulation, Transparency Directive) and the case law of the European Court of Justice.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft). The course can therefore be taken by all students interested in the legal framework of capital markets. It is therefore strongly recommended that students familiarize themselves with the basic concepts of EU law and the functioning of EU institutions.

#### **Performance Report**

The course may be completed with an oral or written examination.

# **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the summer semester.

#### **Linkage to other Module Areas**

# **Essays on European Company Law**

# **Learning Objectives**

Students will write an essay on a current topic in European company law, thereby acquiring in-depth knowledge of the essay topic and a broader understanding of European company law in general.

# **Learning Content**

Content of the course in European Company Law.

#### Type of Knowledge Transfer

The module is held in the framework of a seminar with a written essay as an exam performance.

# **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

# **Performance Report**

The course will conclude with a written essay.

#### **Calculation of Student Workload**

The module requires 1 SWS.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the winter semester.

#### **Linkage to other Module Areas**

# **Epistemologies of the Global South: Contributions to Reconfiguration of African Studies**

#### **Learning Objectives**

The epistemologies of the Global South embody knowledge that has been silenced and repressed as a result of the unfolding of Euromodernism, empire, and colonialism. These resistant epistemologies of the Global South confront the problem of cognitive injustice, i.e., the practice of not recognizing the different ways through which different people make sense of the world and themselves. Therefore, the epistemologies of the Global South are directly linked to the struggles to restore the existence of those people who were subjected to colonialism/coloniality.

# **Learning Content**

Throughout the seminar, the decolonial analytical category of intersectionality and the production of knowledge will be employed as an essential component of decolonization as it highlights how historically and socially produced ways of life and living are exacerbated by race, gender, class, sexuality, religion, disability, and other cultural and political identity vectors. As a decolonial critical practice, intersectionality creates space for marginalized groups to articulate new and old realities from their own standpoints.

#### Type of Knowledge Transfer

The module is held in the form of an advanced seminar in which students are encouraged to actively participate.

# **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course may be completed with a written term paper.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The course will be held in the winter- and summer semester.

#### **Linkage to other Module Areas**

#### **Food and Trade Law**

#### **Learning Objectives**

By the end of the module, students should be familiar with relevant international instruments of the international trade area and be able to apply basic principles of the WTO framework. Furthermore, students should understand the complexities of international trade law.

#### **Learning Content**

This course provides an overview of world trade law, with an emphasis on food aspects. It introduces students to the treaty architecture of the World Trade Organization (WTO) and certain other regional trade arrangements. Topics include the historical, legal, regulatory, and political economy of the international trade framework; the relationship between international and domestic law and regulation, particularly with respect to state arbitration and compliance issues; standard setting; and the WTO dispute settlement system. Special attention is also given to the Agreement on Technical Barriers to Trade and the Agreement on the Application of Sanitary and Phytosanitary Measures.

# Type of Knowledge Transfer

The module is held in the form of a lecture with additional compulsory tutorial, in which students are encouraged to actively participate.

# **Participation Requirements**

Students must have successfully completed the course: Introduction to Food Law + Tutorium

#### **Performance Report**

The course is completed with a written paper.

#### **Calculation of Student Workload**

For the module 4 SWS are required, consisting of 2 SWS for the lecture and 2 SWS for the accompanying tutorial. In addition, students are expected to spend additional time for the preparation and follow-up of the module, as well as for the preparation of examinations.

#### **Credits**

The module is credited with 6 ECTS, of which 4-ECTS are attributed to the lecture and 2-ECTS to the tutorial.

#### **Frequency of Occurence**

The module will be held in the winter- and summer semester.

#### **Linkage to other Module Areas**

#### **Human Rights in Africa**

#### **Learning Objectives**

The objective of the module is to critically examine the structures and processes of African regional systems for the promotion and protection of human rights. Upon completion of this Coursess, students should be able to competently articulate the role of African institutions in the protection of human rights on the continent. In particular, students should be able to consider and respond appropriately to questions such as the appropriateness of the principles and procedures embodied in the documents for African communities.

#### **Learning Content**

The module provides an in-depth introduction to the African human rights system. It examines the legal and institutional framework that constitutes the regional protection of human rights within the African Union and highlights the contours of its monitoring system. Various topics related to implementation, children, refugees, women, LGBTI, and access to information are covered to complement this area of law.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

# **Performance Report**

The course may be completed with an oral examination or written paper.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the summer semester.

#### **Linkage to other Module Areas**

#### **International Commercial Law I**

# **Learning Objectives**

Students will be familiarized with the special legal problems of international commercial disputes. In this context, the basics of conflict of laws are part of the lecture. In addition, students will gain in-depth knowledge of the Convention on Contracts for the International Sale of Goods (CISG) as the most important set of rules for international trade.

# **Learning Content**

History, objectives, functions of international trade law; introduction to major sets of international trade rules; case exercises.

#### Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

# **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course may be completed with an oral examination or a written examination.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### Credits

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the summer semester.

#### **Linkage to other Module Areas**

#### **International Commercial Law II**

#### **Learning Objectives**

In the course, students will cover the legal framework for the resolution and arbitration of international commercial disputes, in particular the implications of the relevant EU regulations (Rome I Regulation, Rome II Regulation, Brussels I Regulation) and the New York Convention on International Commercial Arbitration.

# **Learning Content**

The course includes practical case studies and also includes a moot arbitration hearing.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft). The course is open to all students interested in private international law.

#### **Performance Report**

The course may be completed with an oral examination or a written examination.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### Credits

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the summer semester.

#### **Linkage to other Module Areas**

# International Environmental and Sustainable Development Law

# **Learning Objectives**

The aim of the module is to provide an understanding of international legal and institutional arrangements that focus on environmental management. Students should be familiar with both the theoretical and practical dimensions of the legal framework after completing the module.

# **Learning Content**

The module highlights several key aspects of international environmental law. It provides an introduction to the principles of international environmental law (such as the principle of common but differentiated responsibilities and the precautionary principle), issues related to the protection of the environment (hazardous activities, waste, air pollution), the conservation of the environment (species, biodiversity) and the use/exploitation of environmental resources (trade in animal parts, genetic resources, genetically modified organisms).

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

# **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course may be completed with an oral examination or written paper.

#### **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

# **Frequency of Occurence**

The course will be held in the winter semester.

# **Linkage to other Module Areas**

#### **Introduction to Comparative Law**

#### **Learning Objectives**

Students are introduced to the different legal approaches of various international legal systems and acquire the methodological tools necessary to compare these legal systems.

#### **Learning Content**

History, aims, fUnctions and methods of comparative law; introduction to the characteristics of different legal families; comparative analysis of selected areas of law.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

# **Performance Report**

The course may be completed with an oral or written examination.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the summer semester.

#### **Linkage to other Module Areas**

#### **Introduction to Data Protection Law**

#### **Learning Objectives**

This course introduces the basic legal concepts of data protection and explains how to apply the General Data Protection Regulation. It will help to understand the legal framework of the Data Protection Act.

#### **Learning Content**

The course consists of five parts: Introduction and Basic Structures; General Personal Law and Basic Data Protection; Personal Data and Processing; Justification of Processing; Protection in Public and Private Law.

# Type of Knowledge Transfer

The lecture will be held as a block course.

# **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

# **Performance Report**

The course may be completed with an oral or written examination.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

# **Frequency of Occurence**

The module will be held in the winter semester.

#### **Linkage to other Module Areas**

#### **International Transport Law**

#### **Learning Objectives**

Students will become familiar with the various international conventions governing the carriage of goods as well as the various regulations governing freight forwarding and logistics services. The course will provide a basic understanding of mandatory uniform law, standard terms, and the various national jurisdictions on the subject. It will demonstrate how new technologies challenge the old legal system.

# **Learning Content**

Uniform mandatory law; carriage of goods; transportation and shipping; charter parties; transportation documents; urban and sustainable transportation.

#### Type of Knowledge Transfer

The module is delivered in the form of a lecture in which students are encouraged to actively participate. Students are encouraged to apply their knowledge in group work and discussion sessions.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course may be completed with an oral or written examination.

# **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations. Students are required to participate in group work during the course.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the winter semester.

#### **Linkage to other Module Areas**

#### **Introduction to African Legal Systems**

#### **Learning Objectives**

This module will provide students with an overview of the essential features of various African legal systems, as well as current issues in African jurisdictions. The course serves as an introduction to legal pluralistic jurisprudence for students.

# **Learning Content**

The module provides students with an introduction to various legal systems on the African continent. Substantive discussions of indigenous legal systems, colonial law, and international law will be conducted. Further, issues of legal conflict resolution, access to justice and human rights, good governance and regional integration are addressed. The role of Africa in the global legal order is repeatedly discussed.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course may be completed with an oral or written examination.

#### **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the winter semester.

#### **Linkage to other Module Areas**

The module may be counted in the Module Areas B and D.

#### Introduction to Law and Food Law

#### **Learning Objectives**

At the end of the module, students should be able to distinguish between the branches of a legal system and the different levels of law (national, international, supranational) and analyze their interactions. Likewise, they should be able to describe the roles and functions of the EU institutions, as well as the basics of their historical development and competences.

# **Learning Content**

The aim of the module is to provide students with a comprehensive introduction to law, focusing on EU law, international law and food law. The course is divided into four topics, starting with a basic introduction to law, followed by an introduction to European law and specifically food law. Next, basic information on international law is provided to prepare students for the following courses. Finally, the last topic area provides insights into legal research and legal writing.

# Type of Knowledge Transfer

The module is held in the form of a lecture with additional compulsory tutorial, in which students are encouraged to actively participate.

# **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course is completed with a written paper.

#### **Calculation of Student Workload**

For the module 4 SWS are required, consisting of 2 SWS for the lecture and 2 SWS for the accompanying tutorial. In addition, students are expected to spend additional time for the preparation and follow-up of the module, as well as for the preparation of examinations.

#### **Credits**

The module is credited with 6 ECTS, of which 4-ECTS are attributed to the lecture and 2-ECTS to the tutorial.

#### **Frequency of Occurence**

The module will be held in the winter- and summer semester.

#### **Linkage to other Module Areas**

#### **Introduction to Public International Law**

#### **Learning Objectives**

The goal of the coursess is to enable you to understand the role of legal norms in regulating the behavior of states and individuals in international society, as well as the relationship between domestic law and international law. This goal is achieved through the study of decided cases, legislation, treaty provisions, and scholarly literature referenced in the curriculum.

# **Learning Content**

This course is an introduction to the general problems, sources, and techniques of public international law. Public international law is a system of legal norms designed primarily to regulate relations between sovereign states. For example, public international law defines the minimum standard of treatment that a sovereign state must provide to the nationals of another state within its territory and the responsibilities of one state to another for failure to meet the required standard of treatment. Increasingly, individuals are also a direct concern of international law.

#### Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course is completed with a written paper.

#### **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### Credits

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the winter semester.

#### **Linkage to other Module Areas**

#### **Lectures on English Law**

#### **Learning Objectives**

Each summer semester, a guest lecturer from our partner university, the University of Birmingham School of Law, comes to Bayreuth to present interesting aspects of his or her field as a native speaker.

#### **Learning Content**

Learning Content relates to the subject areas of each current guest lecturer.

#### Type of Knowledge Transfer

The module is held in the form of a one-week block session in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

# **Performance Report**

The course may be completed with an oral or written examination.

#### **Calculation of Student Workload**

1 SWS is required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### Credits

The module is credited with 5-ECTS.

# **Frequency of Occurence**

The module will be held in the summer semester.

#### **Linkage to other Module Areas**

#### **Methods of the English Common Law**

#### **Learning Objectives**

The course provides an overview of the major methods and procedures of English common law. It serves to introduce students to common law techniques, including legal reasoning, interpretation, and the application of precedent.

#### **Learning Content**

Common law is the common law based on judicial decisions and recorded in reports of decided cases, which has been applied by the common law courts in England since the Middle Ages. It has evolved into the legal system that also applies today in the United Kingdom, the United States, and most member states of the Commonwealth. The course examines the major approaches in common law courts through the analysis of decided cases. Each topic is addressed through a key principle and relevant case law. Students examine the normative development of precedents related to the topic. As part of the class, they have the opportunity to work on sample cases to practice legal reasoning.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

# **Performance Report**

The course is completed with a written paper.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

# Social and Political Processes in Africa and Beyond

#### **Learning Objectives**

The module consists of changing courses, therefore there are differences in the thematic orientation. In general, the course serves to analyze different political actors on the African continent.

# Type of Knowledge Transfer

The module is held in the form of a seminar in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

#### **Performance Report**

The course will be completed with a written paper and presentation.

#### **Calculation of Student Workload**

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.

#### **Credits**

The module is credited with 5-ECTS.

#### **Frequency of Occurence**

The module will be held in the winter semester.

#### **Linkage to other Module Areas**

#### Ways of Reading the US Constitution

# **Learning Objectives**

This module provides an introduction to the major topics in U.S. constitutional law, primarily through an in-depth look at the formative case law that informs the constitutional text.

#### **Learning Content**

These lectures provide an introduction to key topics in U.S. constitutional law, primarily through an in-depth look at the formative jurisprudence that has glossed the constitutional text (particularly in light of the outdated Articles of Confederation) to create the current constitutional framework governing (a) the legal relationships among the three branches of the federal government and (b) the constitutional division of power between the states and the federal government. The lectures also address the jurisprudential development of certain key constitutional concepts with respect to the protection of individual rights, such as the right to due process and equal protection of the laws.

# Type of Knowledge Transfer

The module is held in the form of a lecture in which students are encouraged to actively participate.

#### **Participation Requirements**

Students must be enrolled at the University of Bayreuth in the study law (Studium Rechtswissenschaften) or the Bachelor of Law (LL.B./Recht und Wirtschaft).

# **Performance Report**

The course may be completed with an oral or written examination.

#### Calculation of Student Workload

2 SWS are required for the module. In addition, students are expected to spend additional time preparing for and following up on the module, as well as preparing for examinations.
